We welcome interns interested in the values of diversity, equity, inclusion, and justice (DEIJ) and in clean energy, energy policy, and climate change policy.

Position

Acadia Center is seeking motivated undergraduate and graduate students for summer internship positions in the New England region. Interns will work with Acadia Center staff – policy experts, researchers, attorneys, and communications professionals– on projects that directly impact the work of the organization. Depending on the work, interns may have the opportunity to meet with policymakers, attend state hearings and meetings, and work in coalition with other advocates. Projects will be assigned based on skills and interest, but will mostly include the following:

- Providing background research on racial and environmental justice issues that stymie the progress of clean energy and climate action
- Gaining experience in partnership building by identifying groups and priorities of environmental justice, frontline, and communities in Maine and across the northeast region
- Improving communication and writing skills by developing an internal newsletter and occasionally contributing to blogs published by Acadia Center ENews on *Centering Environmental Justice*
- Attending webinars, coalition meetings, and training opportunities available to program staff to gain exposure and understanding in climate and clean energy issues

Interested candidates should possess the following skills:

- Be an upper-level student of an undergraduate program or a graduate student with an interest and enthusiasm for environmental, climate, and clean energy issues.
- Interest in racial and environmental justice issues as well as partnership building
- Experience in using Microsoft Office suites (Word, Excel, and PowerPoint)
- Familiarity with digital media best practices

To Apply

Internship positions are available in Rockport, ME; Boston, MA; Providence, RI; and Hartford, CT. Position will be fully remote, though there may be possibilities for in-person events. Dates and work schedule will be determined individually, but internships are generally full-time for up to 10 weeks in June, July and August. Acadia Center can provide a modest stipend, though all applicants must attempt to qualify (or be eligible to qualify at the time of application) for an established internship funding program. Examples of funding programs include the Massachusetts Clean Energy Center Intern program (available for current or recent graduates of MA colleges and

Interested candidates should send a resume, cover letter detailing their project interest and their internship funding program, and a short (no more than 2 pages) writing sample by April 29 with the subject line "DEIJ Internship" to this email address:
